Important Health Plan Renewal Information

Dear <SIEBEL FIRST NAME>,

Thank you for being a valued Individual & Family Plan member. We have exciting news as we approach the open enrollment period for plans effective January 1, 2024. First, Optima Health changed its name to Sentara Health Plans! This is an effort to unify with our parent company, Sentara Health. Rest assured, your services, access to doctors, and other benefits you've come to expect from us will not change because of this rebrand.

Second, Virginia residents will shop and enroll for Individual & Family Plans during Open Enrollment for the 2024 plan year using Virginia's Insurance Marketplace, a new state-based health benefit exchange. Virginia's Insurance Marketplace will replace the Federal Exchange (healthcare.gov) for Virginia residents. For more information, visit marketplace.virginia.gov, or call 1-888-687-1501.

Your policy renewal date of January 1, 2024 is approaching and we want to make sure that you understand your options for 2023 health plan coverage.

In the next few weeks, you will begin to receive information about your options for renewing coverage with Sentara Health Plans. This will include your new monthly premium amount and any changes to your current plan or benefits. Please note that your monthly premium, deductible, or maximum out-of-pocket amounts you pay are likely to increase or decrease, depending on your plan.

Open enrollment begins November 1, 2023 and ends January 15, 2024. Here are some steps you can take to prepare for enrollment before you receive your 2024 renewal letter:

- Review your current health plan benefits and costs to account for any changes in your healthcare budget and needs.
- Update your contact information, including your email address.

o If you purchased an Off-Exchange plan directly through Sentara Health Plans (formerly Optima Health), you can make updates for 2024 at sentarahealthplans.com/individual. If you purchased your plan through the Health Insurance Marketplace in 2023, for 2024 you will make your plan selections on the new Virginia Insurance Marketplace, at marketplace.virginia.gov. If you need to change your income to ensure you get the correct subsidy in 2024, or have other Open Enrollment questions, call a Personal Plan Advisor at 1-800-741-4825.
